**Re: Muskego Warriors Youth Baseball
8th Annual Invitational Tournament
June 22-24, 2012**

I have attached the invite for our tournament to be held again in Muskego next summer. Once again, getting this out to you a little earlier as it seems we all look to finalize our tourney schedules earlier every year. **Due to popular demand, we are adding a U8 division to our tournament.** We look forward to building on what we started seven years ago, and hopefully, you can join us for the fun.

This year, we are running a Pool Play – three games guaranteed – tourney of eight teams each for U8-U14. A team will play each team in there division on Friday or Saturday. On Sunday, we will seed the teams based on criteria outlined in the rules and have a single elimination format to determine the winner of each division. The tournament will feature 56 teams playing at four different locations in Muskego, which are all within 5-10 minutes of each other: Mill Valley School (MVS), Kurth Park (KP), Muskego High School (MHS) and Horn Field (HF). U8 will play at KP and MVS, U9 and U10 will play at MVS, U11 and U12 will play at MHS, and U13 and U14 will play at MHS and HF. Games at the high school will be played at the baseball and softball diamonds. We are fortunate to have the opportunity to use them.

The tournament will be played using the National Federation/WIAA rules with exceptions and pitching restrictions. U8 will pitch from 43 ft and play on 60' base lengths, U9 and U10 will play with 60' base lengths, U11 and U12 will play with 70' base lengths, and U13 and U14 will play with 90' base lengths. For U11 and up, the base runners will be allowed to lead off.

Individual trophies will be awarded to the first 3 places in each division. We will continue with the tradition of providing some of the best trophies in the area.

This invite will not be sent via US mail, unless a special request is made. Please feel free to share this invite with anyone who might be interested in our tournament, especially all those new 2nd (U8) and 3rd (U9) coaches. Also, if you would like for me to include someone, please provide me with their email address.
